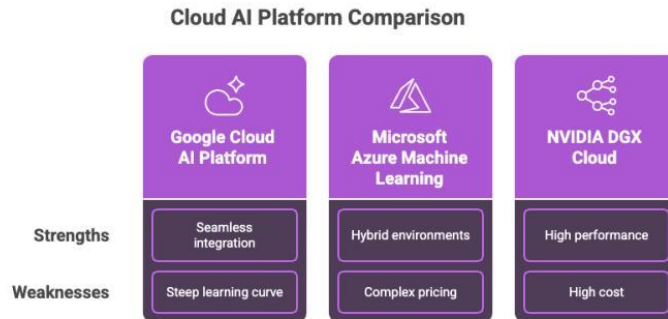


Figure 1 : Cognitive Cloud Computing Architecture
